An Annual Report from the Chairman of the Parish Council:

The Chair's Report was the same as the report the Chairman, Cllr. Z. Mair read out at the Cookley Parish Meeting. The Report is available with these Minutes.

A Report from the County and District Councillor S. Burroughes:

The Suffolk Coastal District Council Annual Report and Current Report are available with these Minutes. They were the same as those distributed at the Cookley Annual Parish Meeting.

However County and District Councillor S. Burroughes added that as Suffolk Coastal District Council is charging for the garden waste bin now, parishioners should now be receiving a bigger bin. He said that he thought the recent meeting with Flagship had been successful and that he believed that there would be another meeting soon. There was some discussion on the issues and it was noted that some tenants are having their heating system changed. County and District Councillor S. Burroughes reported that there was a new plan for work on Sizewell C to begin next year and that there was a new lake in Huntingfield that should lessen flooding further down river in Cookley and Walpole. It was agreed to put this on the agenda of future Parish Council Meeting where road flooding would also be discussed.

Reports from Local Groups & Organisations:

Reports were received from the Cookpole Energy Action Group, the Walpole and Cookley Playing Field Trust, Walpole Allotments, the George Calver Charity, Cookley and Walpole Good Neighbours, the Time Team and the Safer Neighbourhood Team. Their reports are available with these Minutes.

Summary of Parish Council Audited Accounts to 31 March 2018:

The Clerk reported that last year (2016-2017), the Receipts were Precept Income of £5779 which including the carry forward of £5121 from 2015-2016 and other income of £975 equalled £11 875. With payments of £6175, this left a carry forward of £5700 to next year.

The Clerk reported that this year (2017-2018), the Receipts were Precept Income of £8000-00 which including the carry forward of £5700-38 from 2016-2017 and other income of £1914-11 equalled £15 614-49. With payments of £6484-36, this left a carry forward of £9130-13 to next year. At the end of March 2018 the Community Account had £8961-55 in it and the Savings Account £1096-94 totalling £10 058.49. However with four cheques and a £35 that cannot be accounted for from several years ago that totals £928-36, the reconciled amount in the Bank Account is £9130-13.

Local Issues:

It was noted that the Speed Signs were now in place.

Cllr. Cask said that he thought that it would be useful if the postcodes could be published in both Cookley and Walpole. Cllr. Z. Mair said that parishioners had been asked to make the names of their houses prominent. Perhaps the postcode could be put on the sign with the House Name. It was agreed that Cllr. Z. Mair would contact all the parishioners with this request.

Any other business approved by the Chairman:

There was no other business.
