3) **Requests for dispensations:**

4) **Planning Matters:**

Proposal: *Excavate two new wildlife ponds for Great Crested Newt as part of the habitat delivery for Natural England District Level Licencing scheme in Suffolk. Ponds to be excavated to a maximum depth of 2m and to have varying substrate and bank profiles. Arising spoil to be bunded onsite in low bunds to create hibernation sites for Great Crested Newt. Access to the site from Walpole Road along field margins.*
